Lake Louise Christian Community Fireworks Policy

No person shall ignite, discharge, or use any fireworks, as defined in the Michigan Fireworks Safety Act (MCL 28.451 *et seq.*), on property owned by Lake Louise Christian Community. Lake Louise Christian Community will provide an exception such that "consumer fireworks" may be ignited, discharged or used only on July 4 along with the closest weekend (Saturday & Sunday), between the hours of 8:00 AM and midnight. The ignition, discharge or use of "display fireworks" is strictly prohibited at all times. This policy does not prohibit or limit the use of "low-impact fireworks" or "novelties" as defined in the Fireworks Safety Act.

Per the Michigan Fireworks Safety Act, MCL 281.452:

"Consumer fireworks" (i.e., fireworks available for purchase by the general public at Michigan Fireworks stands or stores) means fireworks devices that are designed to produce visible effects by combustion, that are required to comply with the construction, chemical composition, and labeling regulations promulgated by the United States consumer product safety commission under 16 CFR parts 1500 and 1507, and that are listed in APA standard 87-1, 3.1.2, 3.1.3, or 3.5.

"Display fireworks" (i.e., fireworks that require a permit and/or license to purchase and set off) means large fireworks devices that are explosive materials intended for use in fireworks displays and designed to produce visible or audible effects by combustion, deflagration, or detonation, as provided in 27 CFR 555.11, 49 CFR 172, and APA standard 87-1, 4.1.

"Fireworks" means any composition or device, except for a starting pistol, a flare gun, or a flare, designed for the purpose of producing a visible or audible effect by combustion, deflagration, or detonation.

"Low-impact fireworks" means ground and handheld sparkling devices as that phrase is defined under APA standard 87-1, 3.1, 3.1.1.1 to 3.1.1.8, and 3.5.

"Novelties" means that term as defined under APA standard 87-1, 3.2, 3.2.1, 3.2.2, 3.2.3, 3.2.4, and 3.2.5 and all of the following:

- (i) Toy plastic or paper caps for toy pistols in sheets, strips, rolls, or individual caps containing not more than .25 of a grain of explosive content per cap, in packages labeled to indicate the maximum explosive content per cap.
- (ii) Toy pistols, toy cannons, toy canes, toy trick noisemakers, and toy guns in which toy caps as described in subparagraph (i) are used, that are constructed so that the hand cannot come in contact with the cap when in place for the explosion, and that are not designed to break apart or be separated so as to form a missile by the explosion.
- (iii) Flitter sparklers in paper tubes not exceeding 1/8 inch in diameter.
- (iv) Toy snakes not containing mercury, if packed in cardboard boxes with not more than 12 pieces per box for retail sale and if the manufacturer's name and the quantity contained in each box are printed on the box; and toy smoke devices.
